## **Red Orchard Park Barn Rental FAQs**

- 1) What area, if any, surrounding the barn is reserved for events?  
No areas are specifically reserved but any open green space can be used.
- 2) Are there any signs stating that an event is in progress, etc. to request quiet/no barging in from the public?  
The Parks department does not post any signage.
- 3) Is there any way to reserve/block off the parking spaces adjacent to the barn from the public, etc.?  
Parking areas are open to all park users and cannot be blocked off for events.
- 4) Are there any restrictions on decorations?  
Any decorations can be added but what is in the barn at the time of your arrival must remain by your departure.
- 5) Are there any restrictions on vendors?  
No, you can use any vendor that you would like.
- 6) Are there any restrictions on photos regarding where we can take them on the property?  
No, all open areas of the park are welcomed for photographs.
- 7) Is the barn checked for cleanliness prior to the date?  
Yes, the barn is cleaned prior to your arrival.
- 8) Are the restrooms cleaned?  
Yes and are continually cleaned on an as needed basis. These are public restrooms.
- 9) Will there be anyone available to help on the day of the event?  
The Parks department does not provide anyone nor anything to help with setup or take down for your event.
- 10) Will we have a contact person on the event weekend to be able to call if there is a problem?  
The main office is your contact. 502-633-5059
- 11) Will any rented items (tables, chairs, etc.) be in the barn upon our arrival?  
Yes, all equipment rented from the parks department will be in the barn prior to the rental.

- 12) What clean-up is required?  
The barn should be left like it was found. Garbage should be left for parks department to pick up.
- 13) Do you allow any candles or fireworks?  
Candles and fireworks are allowed in open areas.
- 14) Can both barn doors be opened or closed?  
Yes.
- 15) Is there a kitchen?  
No.
- 16) I noticed there are “haunted barn” events in the Fall on the website. Would that interfere with renting the barn?  
No. Parking areas and the restrooms are the only shared areas.
- 17) Can we rent fans or heaters?  
Yes.
- 18) Where do guests park?  
Parking is done in the field to the left of the barn as well as the field behind the barn.
- 19) Is there a limit on guests or maximum capacity?  
The barn is not recommended for more than 250 people.
- 20) Is the Miller Outdoor Education Center (white house on front of property) available during my event?  
No. The Miller Outdoor Education Center cannot be used for your event.
- 21) Can the road next to the barn be blocked off?  
No, not without permission from the parks department.
- 22) Can the park be closed off to the public for my event?  
No.
