Park Property: Report attached.

Clear Creek – July 15th RobFest was held at the Amphitheatre. Instructional field lights have been installed thanks to a donation from Allen & Rena George. C3 has ended and served 598 kids over 8 weeks. There will be a dedication for Phase II of the playground on August 29th at 1pm. SprayTec has been back to patch the FAC roof which is still in need of replacement of approximate \$300,000. The pool is shut down for annual cleaning, painting and maintenance, the outdoor pool is still available. A banner will be hung for the Stingrays at the pool in honor of their past 3 state wins. There was a FAC member luau on July 30th which was free for members.

Lake Shelby – The next fish fry will be on August 18th. Eagles scouts will be constructing canoe racks.

Red Orchard – Construction continues on the haunted barn. The danger run team is holding auditions for actors. EMS is hosting a tactical training course in the back of the park. The dog park road will receive new rock.

Department Heads:

Park Consultant – Clay Cottongim: Shelby Trails mowing continues. There have been new pastures fenced by Penrod. \$11,879 from the Boots & Bridles Gala funded this project as well as waterlines to these pastures. The MOA for the Greenway is ready to be printed and signed. Work can begin 30 days after signature. Bids will go out next week and be awarded in mid Septemeber. Woofstock is on Saturday, September 16th from 10-3. \$135,000 has been raised since February through the Greenway, Parks Poker Pedal and Boots and Bridles Gala.

Athletics – Chip Minnis: Fall sports signups have ended. There are 265 enrolled in soccer, 128 in baseball. Soccer will begin the 26th of August, baseball will begin the Tuesday after Labor Day. Football has begun playing and will have their first home game on the 12th. 30 helmets were stolen from storage which is approximately worth \$4,200.

Trailblazers – Jerry Scrogham: Master Gardener students will be planting and landscaping at the Miller Center. October 28th is the date for the Trick or Treat trail, fall programming in the works.
